## AGENDA ITEMS

#### Club Cycling Kit Review:

*Lynsey provided a brief update on the ongoing redesign of the club kit:* 

The design team have reviewed the "Club brand" and have drawn on this to produce a template for the design of Jerseys and shorts. Matt O'Connor's design team are using the template to produce three options; similar to the existing design minus sponsor details, a refreshed design using the same colour palette, and a more radical design using the same colour palette. The committee will be updated once the designs are ready for review.

Paul asked if the existing kit will be registered with British Cycling for the 2023 season. As a new design can be submitted once the season has started the committee agreed to stick with the existing kit and register the new design once the kit is available to members.

As there is currently a surplus of the current kit, the committee agreed that an email would be sent to all members including a table of the available items and detailing the discounted price for each.

#### Cameras:

Consideration of the provision of front and rear facing cameras for ride leaders.

Alan Salisbury and Matt O'Connor had updated the Executive committee of a road rage incident on one of the Club rides. Consequently, Alan and George have had early discussions regarding the possibility of providing cameras to ride leaders.

The following discussion of the effectiveness of cameras, their limitations and any potential data protection issues, committee agree that if the provision of cameras was requested by a ride leader as a condition of their continued support, then the Ride Captain should have the authority to purchase front and rear facing cameras. The need for further cameras to be considered on a case by case basis by the Ride Captain



### Youth Rides:

Recent interest in the provision of youth rides.

George reported that there has been a recent increase in the number of enquiries from parents of 14 to 18 year olds seeking information on whether the club offers youth rides. Unfortunately, this is not something we currently offer and discussion with the committee concluded that, whilst we may run a youth section in the future, it will require volunteers to step forward and volunteer to run it. In addition, all of the necessary DBS checks, insurances and coaching certificates would need to be in place.

It was felt that by encouraging younger members with children to join the club, it may be possible, in the future, to support them in bringing their children along and supporting them with the development of a youth section.

One of the club's members (Dave Barker) has experience in coaching and may be able to provide further advice. George will follow-up this issue with Alan and Dave.
